OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

1. Who is eligible?

This sweepstakes is open only to legal US residents who are 18 or older as of **January 1, 2012**. The sweepstakes is void where prohibited. Employees of the International Mountain Bicycling Association (IMBA) (The Sponsor), IMBA-affiliated chapters, employees of prize-providing organization Trek Travel (The Prize Provider), their subsidiaries and affiliates, or of other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

2. Who is sponsoring the Sweepstakes?

The Sweepstakes is sponsored by IMBA, 207 Canyon Boulevard, Suite 301, Boulder, CO 80302 (the "Sponsor"). The prize is provided by Trek Travel, LLC. 613 Williamson St. #207 Madison, WI 53703.

3. How do I enter?

The Sweepstakes runs from **12:00 am (MT) on January 1, 2012 to 11:59 p.m. (MT) on December 1, 2012** (the "Entry Period"). During the Entry Period there are three ways to enter: Method 1: Complete an entry form at an event where IMBA or an IMBA-affiliated chapter is exhibiting. The form also offers a membership to IMBA, but no purchase is required. Method 2: Sign up online for IMBA eNews or Action Alerts at imba.com. Method 3: Handprint the entrants name and address on a postcard and it mail to: by IMBA Raffle, 207 Canyon Boulevard, Suite 301, Boulder, CO 80302. All mail-in entries must be postmarked between **January 1, 2012** and **December 1, 2012** and received by **December 1, 2012** to be included in the pool that we will draw from for prizes at the end of the Entry Period.

4. How will winners be selected?

On or about **December 31, 2012**, a representative from IMBA will select a potential winner in a random drawing of all entries received. The odds of winning depend on the number of eligible entries received. The potential winner will be notified within 10 days of the drawing.

5. What can I win?

Winner will each receive a prize 4 day/3 night Trek Travel "Moab Road & MTB Long Weekend" bicycling trip for two people to Moab UT, as described at <http://www.trektravel.com/moab-weekend-bike-tour.php>.

Total approximate retail value: \$3,200.

Any prize details not specified above will be determined by the Prize Provider in its sole discretion. Travel to and from the trip's starting point is not included. Prizes are not transferable and must be accepted as awarded. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. ***The winner is responsible for taxes and any and all other costs and expenses not listed above in the trip description or on the Prize Provider's web site, including transport to and from the trip's starting point.***

6. What may a potential winner be required to do?

Except where prohibited, a potential winner may be required to complete and return a Declaration and Release and/or tax form W-9, if applicable, within five (5) days of being notified. If a potential winner declines to accept the prize, has violated any of these Official Rules, or fails to sign and return the required documents within the required time period, then an alternate entrant will be selected in his/her place in a random drawing of remaining entries.

What other terms should I be aware of?

By participating in the Sweepstakes, entrants agree to be bound by these Official Rules and the determinations of Sponsor, which shall be final. Unless prohibited by law, entrants agree to allow use of their name, voice, city/state of residence, photograph, and/or likeness for advertising and/or trade and/or any other purpose in any media or format now or hereafter known without further compensation, permission or notification.

The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited by law. In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize at random from among the eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right to modify or cancel this promotion at any time and, in the event of cancellation, substitute another in its place.

By participating in the Sweepstakes, entrants agree to release and hold harmless the Sponsor, prize providers and related organizations or volunteers, and their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the

Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

7. How will disputes be handled?

Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Colorado. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Colorado, without giving effect to any choice of law or conflict of law rules (whether of the State of Colorado or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Colorado.

8. How can I find out who won?
